

End User License Agreement

THE COPYRIGHT AND OTHER INTELLECTUAL PROPERTY RIGHTS IN THIS SOFTWARE ('THE SOFTWARE') AND ITS ASSOCIATED DOCUMENTATION ARE OWNED BY STARLOGIC LIMITED ('STARLOGIC'). PLEASE READ THROUGH THE FOLLOWING LICENSE TERMS. BY ACCEPTING THE LICENSE TERMS, YOU ARE CONSENTING TO BE BOUND BY THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CLICK THE "CANCEL" BUTTON AND THE INSTALLATION PROCESS WILL NOT CONTINUE.

1. License

1. StarLogic hereby grants you a non-exclusive, non-transferable license to use the Software in accordance with the agreement constituted by your acceptance of these terms ('this Agreement').
2. You are permitted to:
 1. load the Software into and use it on not more than two computers which are under your control and which meet the specifications of which you will find details on StarLogic's website at www.chef365.com;
 2. remove the Software from one computer and reinstall it on another provided it is not used on more than two computers at any one time;
 3. make up to five copies of the Software for back-up purposes only. The copies must reproduce and include StarLogic's copyright notice. Such copies and the media on which they are stored shall be the property of StarLogic and this Agreement shall apply to all such copies as it applies to the Software.
3. You are not permitted:
 1. to use the Software on a network or to load the Software on to a network server whether for the purposes of distribution to one or more other computer(s) on that network or otherwise;
 2. except as expressly permitted by this Agreement and save to the extent and in the circumstances expressly permitted by law, to rent, lease, sub-license, loan, copy, modify, adapt, merge, translate, reverse engineer, decompile, disassemble or create derivative works based on the whole or any part of the Software or its associated documentation or use, reproduce or deal in the Software or any part thereof in any way;
 3. to assign or otherwise transfer all or any part of this Agreement or all or any part of your rights or obligations hereunder without the prior written consent of StarLogic.

2. License fee

1. You will find details of the fee for the use of the Software ('the License Fee') and payment methods on StarLogic's website at: www.chef365.com or by emailing StarLogic at sales@starlogic.co.uk.

3. Activation and evaluation

1. Except as provided in paragraphs 3.2 and 3.3 you may not use the Software on any computer until it has been activated in relation to that computer. The Software will not be activated until you have paid the License Fee and have submitted to StarLogic your name e-mail address and a unique computer-generated code.
2. The Software will operate for a limited evaluation period without activation to enable you to evaluate the Software. You acknowledge that, as StarLogic is permitting you to use the Software free of charge for evaluation purposes, StarLogic does not give any warranty or make any representation in respect of the Software or its functionality or performance unless and until it shall have been activated in accordance with paragraph 3.1.
3. You agree that you will not, prior to the activation of the Software in accordance with paragraph 3.1, make any use of the Software except for the purposes of evaluation and that if you shall use the Software for any other purpose, you shall do so at your own risk and expense and shall fully and effectively indemnify StarLogic in respect of the consequences of such use.
4. It will be necessary for you to activate the Software by applying to StarLogic for an activation code when the Software is installed on a computer for the first time or, in certain circumstances, when it is re-installed on a computer. StarLogic reserves the right to refuse to issue an activation code if in Starlogic's opinion you have made an

unreasonable number of requests for an activation codes. Requests for activation codes should be made by e-mail to: activate@chef365.com.

4. Copyright and other rights

1. You acknowledge that any and all of the copyright, patent, trade secrets or any other intellectual property rights (herein referred to as 'IP Rights') subsisting in or used in connection with the Software including its associated documentation are and remain the sole property of StarLogic.
2. To the extent that local law gives you the right to decompile the Software in order to obtain information necessary to render the Software interoperable with other computer programs, StarLogic hereby undertakes to make that information readily available to you. StarLogic shall have the right to impose reasonable conditions such as a reasonable fee for doing so. In order to ensure that you receive the appropriate information, you must first give StarLogic sufficient details of your objectives and the other software concerned.
3. StarLogic will indemnify you against any claim that the normal use or possession of the Software infringes the IP Rights of any third party Provided that StarLogic is notified promptly in writing of any such claim; StarLogic is given immediate and complete control of such claim; you do not prejudice StarLogic's defence of such claim; you give StarLogic all reasonable assistance with such claim (at StarLogic's cost); and such claim does not arise as a result of the use of the Software in combination with any equipment or programs not approved by StarLogic.
4. StarLogic will have the right to replace or change all or any part of the Software in order to avoid any infringement or potential infringement of the IP Rights of any third party.
5. The above states the entire liability of StarLogic with respect to the infringement or contravention or alleged infringement or contravention by the Software of the IP Rights of any third party.

5. Warranty

1. StarLogic warrants that the Software will have all of the material functions described in, and will perform in all material respects in accordance with, its associated online help documentation.
2. If within a period of 90 days of the date of payment of the License Fee you notify StarLogic that the Software or any part of the Software does not comply with the above warranty StarLogic will at its sole option either refund the License Fee or use all reasonable efforts to correct within a reasonable time by patch or new release (at its option) that part of the Software which does not comply with the warranty Provided that such non-compliance shall not have been caused by any modification, variation or alteration of the Software not authorized by StarLogic or caused by incorrect use of the Software or by the use of the Software with other software or on any computer or computer system with which it is incompatible.
3. StarLogic does not warrant that the Software will meet your requirements or that the Software or the operation of the Software will be error free or uninterrupted or that defects in the Software will be corrected. StarLogic will not be liable for any failure of the Software to provide any functions not specified in its accompanying documentation.
4. StarLogic may (but shall not be obliged to) make available for download from its website (www.chef365.com) free of charge releases or patches to correct bugs or errors in the Software or to enhance the Software. StarLogic will supply copies of such releases or patches on disk or other physical media at its usual charges. StarLogic shall not be obliged to inform you of the availability of such releases or patches.
5. The above represent your sole remedies for any breach of StarLogic's warranty.

6. Limitations

1. The terms of this Agreement are in lieu of all warranties, conditions, undertakings, terms and obligations implied by statute, common law, trade usage, course of dealing or otherwise all of which are hereby excluded to the fullest extent permitted by law.
2. Except in respect of death or personal injury resulting from StarLogic's negligence or breach of these terms StarLogic will not in any circumstances be liable under this Agreement, whether in contract, tort (including negligence or breach of statutory duty) or otherwise and whatever the cause thereof:

3. for loss of production, loss of or corruption to data, loss of revenue, profits, business or contracts, loss of operation time, loss of goodwill or anticipated savings; or
 4. for any special, indirect or consequential loss or damage of any nature whatsoever, even if StarLogic has been advised of the possibility thereof.
 5. Except in respect of death or personal injury resulting from StarLogic's negligence or breach of these terms and in respect of the tort of deceit (for which no limit applies) StarLogic's total liability (whether in contract, tort, including negligence or breach of statutory duty, or otherwise) under or in connection with these terms (whether based on any claim for indemnity or contribution or otherwise) will not exceed 125% of the License Fee.
7. Support
1. StarLogic will endeavour to provide by e-mail any technical assistance which you may require regarding the use of the Software or its functionality or performance for a period of 60 days after your first e-mail requesting such technical assistance, which must be made within the period of 90 days referred to in paragraph 5.2. Requests for assistance should be sent by e-mail to: support@chef365.com.
 2. While you are evaluating the Software in accordance with paragraph 3 technical assistance will be limited to installation support.
 3. Term and termination
 4. This Agreement is effective until you terminate it by destroying the Software and its documentation and all copies thereof. It will also terminate if you fail to abide by its terms.
 5. Upon termination you agree to destroy all copies of the Software and its associated documentation.
8. Miscellaneous
1. StarLogic shall have the right to disclose to third parties for marketing purposes (whether orally or in print or by means of the Internet) the fact that you are a licensee of the Software.
 2. No forbearance, delay or indulgence by either party in enforcing the provisions of this Agreement shall prejudice or restrict the rights of that party nor shall any waiver of its rights operate as a waiver of any subsequent breach and no right, power or remedy herein conferred upon or reserved for either party is exclusive of any other right, power or remedy available to that party and each such right, power or remedy shall be cumulative.
 3. The parties confirm that except as expressly provided in this Agreement they do not intend to confer any rights on any third parties by virtue of this Agreement and accordingly except as expressly provided the Contracts (Rights of Third parties) Act 1999 shall not apply to this Agreement.
 4. This Agreement shall be governed in all respects by the laws of England
